#### Audit opinion - Qualified

Except for the matters reported below in my Basis for Qualification\* on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
  of resources.

#### **Basis for Qualification**

In my opinion:

- The Council has not complied with the Public Audit (Wales) Act 2004:
  - The Council did not publish a notice to disclose the late certification of the Annual Report by the Clerk and the Chair of the Council: and
  - The Annual Report was approved after the commencement date for exercise of electors rights.

#### Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

- Asset Register:
  - We note that the fixed asset register is not complete and does not agree to the value included within the Annual Return. We recommend that the Council reviews its assets and ensures all assets are properly recorded.
- Council meetings:
  - We have noted that there were no meetings from March 2021 to November 2021 due to the COVID
    pandemic. Due to this and lack of available minutes we have been unable to confirm financial regulations
    and standing orders have been adhered to during the year.
  - We have also noted that the Clerk's employment contract has not been signed which should be rectified as a matter of urgency.
